RESCHEDULING THE MAY 2022 DENTISTS LICENSURE EXAMINATION (DLE) PRACTICAL PHASE FROM 08–15 MAY 2022 TO 10–17 MAY 2022 AND EXTENDING THE DEADLINE OF APPLICATION FOR THE DLE PRACTICAL PHASE

WHEREAS, Section 7 (d) of Republic Act No. 8981 or the "PRC Modernization Act of 2000" empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

WHEREAS, the Commission issued Resolution No. 1439 (s. 2021) scheduling the Dentists Licensure Examination (DLE) for the Written Phase on May 4, 5, and 6, 2022 in Baguio, Cebu and National Capital Region (NCR) and the Practical Phase on May 8-15, 2022 in NCR only, with the deadline of filing of applications on April 04, 2022;

WHEREAS, in a Memorandum dated April 01, 2022, the Board requested to change the examination dates of the Practical Phase from May 08-15, 2022 to May 10-17, 2022 to give way to the national elections which is slated on May 09, 2022;

WHEREAS, in another Memorandum dated April 03, 2022, the Board likewise proposed to extend the deadline for the filing of applications for the DLE Practical Phase in order to accommodate those who failed in said examination prior to the effectivity of Board Resolution No. 02 (s. 2021);

WHEREAS, the Board and the Licensure Office, after consultation, agreed on the following recommendations: to reschedule the May 8-15, 2022 DLE Practical Phase and to extend the deadline for the filing of applications for the May 2022 DLE Practical Phase;

WHEREFORE, upon motion duly made, the Commission hereby **RESOLVES** to:

1. **RESCHEDULE** the May 2022 Dentists Licensure Examination – **Practical Phase** from May 08 -15, 2022 to **May 10 – 17, 2022**;
2. **EXTEND** the deadline for the filing of applications for the **DLE-Practical Phase only** from April 04, 2022 to **April 22, 2022** to accommodate those who failed in said examination prior to the effectivity of Board Resolution No. 02 (s. 2021).

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
