**RESOLUTION NO. 1524**

**DESIGNATING DAVAO CITY AS AN ADDITIONAL TESTING CENTER FOR THE  
AUGUST 2022 GUIDANCE COUNSELORS LICENSURE EXAMINATION**

**WHEREAS**, Section 7 (d) of Republic Act No. 8981 or the “PRC Modernization Act of 2000” empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and **to determine and fix the places and dates of examinations**;

**WHEREAS**, pursuant to Resolution No. 1439 (s. 2021), the scheduled Guidance Counselors Licensure Examination (GCLE) will be on August 17 and 18, 2022;

**WHEREAS**, there were 27 examinees who individually requested the Commission’s Davao Regional Office, thru its Regional Director, to consider Davao City as one of the testing centers for the August 2022 GCLE;

**WHEREAS**, the Commission issued Resolution No. 1493 (s. 2022) which provides that additional testing centers for small-scale examination within the city or province where a Regional Office is located must have at least 25 prospective examinees;

**WHEREAS**, the GCLE is a small-scale licensure examination, as defined in Commission Resolution No. 1256 (s. 2020), and there are, more or less, 27 prospective examinees for the August 2022 GCLE in Davao City;

**WHEREAS**, the Commission’s Davao Regional Office, in its July 13, 2022 Memorandum, expressed that it has no objection to the said request;

**WHEREAS**, the Professional Regulatory Board of Guidance and Counseling and the Licensure Office recommend the approval of the request in order to give the concerned examinees the opportunity to take the August 2022 GCLE without unnecessary distant travel and additional expenses;

**WHEREFORE**, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to designate **DAVAO CITY** as an additional testing center for the **AUGUST 2022 GUIDANCE COUNSELORS LICENSURE EXAMINATION**.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
