**DESIGNATING ZAMBOANGA CITY AS AN ADDITIONAL TESTING CENTER FOR  
THE SEPTEMBER 2022 LIBRARIANS LICENSURE EXAMINATION**

**WHEREAS**, Section 7 (d) of Republic Act No. 8981 or the “PRC Modernization Act of 2000” empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and **to determine and fix the places and dates of examinations;**

**WHEREAS**, pursuant to Resolution No. 1439 (s. 2021), the scheduled Librarians Licensure Examination (LLE) will be on September 12 and 13, 2022 to be held in the National Capital Region, Baguio, Cagayan de Oro, Cebu, Davao, Iloilo, Legazpi, Lucena, Rosales, Tacloban and Tuguegarao;

**WHEREAS**, the Bachelor of Librarians and Information System Program Head of Pilar College of Zamboanga City requested the Professional Regulatory Board for Librarians (Board) and the Commission to consider Zamboanga City as one of the testing centers for the September 2022 LLE;

**WHEREAS**, the Commission issued Resolution No. 1493 (s. 2022), otherwise known as the “Revised Guidelines and Procedures on the Designation of Additional Testing Centers for the Conduct of Local Licensure Examinations”, which provides that additional testing centers for small-scale examination within the city or province where the PRC Regional Office is located must have at least 25 prospective examinees;

**WHEREAS**, LLE is a small-scale licensure examination and there are more or less forty-five (45) prospective examinees for the September 2022 LLE in Zamboanga City;

**WHEREAS**, PRC Pagadian Regional Office, in its July 4, 2022 Memorandum, expressed that it has no objection to the said request;

**WHEREAS**, the Board and the Licensure Office recommend the approval of the request in order to give the concerned examinees the opportunity to take the September 2022 LLE without unnecessary distant travel and additional expenses;

**WHEREFORE**, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to designate **ZAMBIOANGA CITY** as an additional testing center for the **September 2022 Librarians Licensure Examination**.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
